JUDGMENT AND ORDER

- 1. Pursuant to a Claim Form made on 7 November 2025 the Claimant seeks an Order from this Court to recognise and enforce the measures set forth in para 20 of the IAC Arbitration Award dated 14 August 2025 made by Ms. Indira Yeleusizova, the sole arbitrator appointed by a letter dated 8 July 2025 of Mr. Thomas Krümmel, the Chairman of the AIFC International Arbitration Centre, in IAC Arbitration Case No. 127/2025.
- 2. Having read the Award it appears to me that the application is justified. Accordingly, I hereby order:
 - 1) the total debt of IE "SK-VENT", Konstantin Georgievich Grishin, Kristina Kunitsyna, "VENT-HOUSE PLUSE" LLP, and "VENT-HOUSE.KZ" LLP to Vadim Evgenievich Miropolsky amounts to KZT 1,264,000 (one million two hundred sixty-four thousand) and shall be paid jointly and severally by IE "SKVENT", Konstantin Georgievich Grishin, Kristina Mikhailovna Kunitsyna, "VENT-HOUSE PLUSE" LLP, and "VENT-HOUSE.KZ" LLP in 1 (single) payment no later than 31 August 2025;
 - 2) In case of improper fulfilment of the Settlement Agreement by IE "SK-VENT", Konstantin Georgievich Grishin, Kristina Mikhailovna Kunitsyna, "VENT-HOUSE PLUSE" LLP, "VENT-HOUSE.KZ" LLP:
 - Vadim Evgenievich Miropolskiy in addition to the existing debt specified in paragraph 1 of the Settlement Agreement, a penalty shall be charged on the amount of overdue payment(s) at the rate of 0.1% (zero point one percent) for each calendar day of delay.
- 3. The Defendants are given liberty to apply to have this Order set aside within 14 days of service upon it ofthis Order.
- 4. This Order shall not be enforced (a) until after the end of the period set out in paragraph 3 above or (b) until after any application made by the Defendant within that period has been finally disposed of, whichever is the later.
