## JUDGMENT AND ORDER

- 1. Pursuant to a Claim Form made on 7 November 2025 the Claimant seeks an Order from this Court to recognise and enforce the measures set forth in Part V of the IAC Arbitration Award dated 2 October 2025 made by Ms. Elena Nesterova, the sole arbitrator appointed by a letter dated 27 June 2025 of Mr. Thomas Krümmel, the Chairman of the International Arbitration Centre, in IAC Arbitration Case No 98/2025.
- 2. Having read the Award it appears to me that the application is justified. Accordingly, I hereby order:
  - To recover jointly and severally from Livandovskiy Boris Bronislavovich (IIN 750718301344), Nikulin Maksim Vladilenovich (IIN 770823350337), Limited Liability Partnership "AGRONAVIGATOR" (BIN 201040000310), and Limited Liability Partnership "DONETSKOE KOLLEKTIVNOE HOZYAISTVO" (BIN 151240004011) in favour of Yeleussizov Timur Zhaksybaevich (IIN 780813302661):
    - the amount of the principal debt, remuneration, and penalties in the total of KZT 7,100,750 (seven million one hundred thousand seven hundred fifty);
    - the arbitration costs in the amount of KZT 339,608 (three hundred thirty-nine thousand six hundred eight).
  - 2. To dismiss the claims of Yeleussizov Timur Zhaksybaevich (IIN 780813302661) against the Private Company "Digital Agro Ltd." (BIN 210640900100).
- 3. The Defendant is given liberty to apply to have this Order set aside within 14 days of service upon it of this Order.
- 4. This Order shall not be enforced (a) until after the end of the period set out in paragraph 3 above or (b) until after any application made by the Defendant within that period has been finally disposed of, whichever is the later.
