ADDITIONAL JUDGMENT AND ORDER

1. I gave a judgment in respect of these cases on 30 April 2026 and invited the parties to agree a draft Order. They have been unable to do so, and have made submissions to the Court as to the Order I should make.
2. I have considered those submissions.
3. I do not agree with the criticisms by Mr Abramov and Eurasia GAZEXPORT in relation to the draft Order submitted by Tethys. I will, however, omit any reference to joint and several liability in the Order below. Liability of more than one party to make a payment will be joint and several unless otherwise specified.
4. I do not consider that there is any injustice in the addition of the sums of KZT 5,000,000.00 and KZT 9,000,000.00 to make KZT 14,000,000.00 in the draft Order submitted by Tethys.
5. I therefore order:
 - 1) DSKF SPECIAL FINANCE COMPANY LLP shall pay TETHYS PETROLEUM LIMITED and TETHYSARALGAS LLP post-judgment interest on the amount of KZT 1,434,692,762.00 at 8% from 12 June 2025 until 23 February 2026, resulting in accrued interest of KZT 80,500,021.28;
 - 2) DSKF SPECIAL FINANCE COMPANY LLP AND OLISOL PETROLEUM LIMITED shall pay TETHYS PETROLEUM LIMITED AND TETHYSARALGAS LLP post-judgment interest on the amount of EURO 50,000.00 at 2.15%, from 12 June 2025 until 23 February 2026, resulting in accrued interest of EUR 753.97;
 - 3) DSKF SPECIAL FINANCE COMPANY LLP and OLISOL PETROLEUM LIMITED shall pay TETHYS PETROLEUM LIMITED and TETHYSARALGAS LLP post-judgment interest on the amount of KZT 50,000,000.00 at 8% from 12 June 2025 until 23 February 2026, resulting in accrued interest of KZT 2,805,479.45;
 - 4) DSKF SPECIAL FINANCE COMPANY LLP shall pay TETHYS PETROLEUM LIMITED and TETHYS ARALGAS LLP post-judgment interest on the amount of KZT 10,000,000.00 at 8% from 27 February 2026 until the date of actual payment;
 - 5) Mr Alexander Abramov and Eurasia GAZEXPORT LLP shall pay TETHYS PETROLEUM and TETHYSARALGAS post-judgment interest on the amount of KZT 14,000,000.00 at 8% from 27 February 2026 until the date of actual payment;
 - 6) DSKF SPECIAL FINANCE COMPANY LLP, Mr Alexander Abramov, Eurasia GAZEXPORT LLP and Mr Fedor Ossinin shall pay TETHYS PETROLEUM LIMITED and TETHYSARALGAS LLP post-judgment interest on the amount of KZT 12,500,000.00 at 8% from 27 February 2026 until the date of actual payment.
